Sub:- Violation of provision of Mineral Conservation and Development Rule 2017 in respect of Sakara Kyanite & Silimanite Mine over an area 11.35 ha , (Mine Code- 33MSH 05022) situated near Sakara village of Lakhandur Tehsil, Bhandara, District of Maharashtra- reg.

Sir,

The following provisions of Mineral Conservation and Development Rule, 2017 (MCDR, 2017) were found violated in respect of the above said mine during inspection on 06.09-2021 by A.K.Patel AMG.

Rule	Nature of Violation observed
12.(4)	In the case of existing mining leases detailed exploration (G1 Level) over the entire potentially mineralized area under the mining lease shall be carried out within a period of 5 years from the date of commencement of these rules. You have done the detailed exploration.
55.(c)	<u>Restoration of flora</u> ,Target for plantation is not achieved as per mining plan. (i) Category 'A' mines whole time mining engineer and geologist (ii) category 'B' mines whole time mining engineer and geologist, For the purpose of caring out mining operation, Geologist and mining engineer is required. Geologist was on leave/not present during inspection.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.
03. The mining operations can be suspended under Rule 11(2), if compliance of MCD Rules 2017 is not found satisfactory, or prosecution can be made, or both can be done.
04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty Five) days from the date of issue of this letter.
