Violation of Sub: provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) in respect of Kolimigundla Limestone mine of over an extent of 4.048 ha in Kolimigundla Village and Mandal, Kurnool District, Andhra Pradesh.

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the MCDR inspection on 29.10.2021 by the undersigned accompanied with Shri J.Ashok, Mines Manager

	Discrepancies observed in the Annual return submitted for the financial year 2020-21 are as below:  Part I, Item No.12: In Point No.(i), area exploited & abandoned is furnished as 2.84 ha whereas no such abandoned area is observed in the field.  In Point No (ii), area under current workings is furnished as '0' whereas the above 2.84 ha is under current workings.  In Point No (iv), area under waste disposal is furnished as 0.020 whereas no waste dump is observed in the field.  In Point No(v), area under infrastructure is furnished as 0.942 ha whereas no infrastructure is observed in the field.
	Part V, Item No.3, Reserves and resources are not in consonance with that of Approved Modified Mining Plan.  Part V, Item No.4.2 (B), Total ROM ore production is furnished as 156573 tonnes but it is 147570 tonnes as per the monthly returns submitted to this office for the year 2020-21.  this connection, it is brought to your notice that the characteristics is a submitted to the

- 03. You are, therefore, directed to show cause within a period of 30 (Thirty) days from the date of issue of this letter, as to why all mining operations and dispatches should not be suspended under Rule 45(7)(a)(i) of MCDR, 2017.
