Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Bhimgoda Limestone Mine, Mining lease over an area of 8.55 ha located near Village-Bhimgoda, Taluka-Paonta Sahib, in Sirmour district of Himachal Pradesh State.

महोदय Sir.

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection made by the undersigned on 24.01.2020 in the presence of Shri Ashok Tomar, representative of lessee and the same was communicated to you vide our letter of even number dated on 11-03-2020

RULE NO.

NATURE OF VIOLATION OBSERVED

11(1)

Mining operation were not carried out in accordance with the approved modified mining plan vide letter no 614(2)/MP-B-210/05-DDN dated 11.10.2017 to the following extent:

- (i) As per proposal during the year 2018-19, it was proposed to carry out 01 DTH holes 20 mtrs depth, but during the inspection it was observed no such DTH drilling carried out during the year 2018-19.
- (ii) As per proposal during the year 2018-19, it was proposed to carry out mining operation from 1994 to 1970 mRL by formation of benches 6 mtr height. During the inspection height of benches has been observed up to 10 mtrs whereas as per approved modified mining plan it should be six meter
- Every holder of a mining lease shall monitor his mining and allied activities as per the notified template of star rating in the format prescribed in this behalf by the Indian Bureau of Mines from time to time, and shall submit online its self assessment report before the 1" day of July every year for the previous financial year, along with the soft copy (in standard format), of high resolution satellite images obtained from CARTOSAT-2 satellite LISS-IV sensor on the scale of cadastral map, as on the 31st day of march for that financial year, covering the mining lease and an area of two kilometers from the lease boundary, to the Regional Controller or the authorized of the Indian Bureau of Mines. Whereas holder of the mining lease has not submitted by the online self assessment report and the satellite images as per rules.
 - Every holder of mining lease shall employ a geologist in the mine. But geologist has not been appointed in the mine.
- However, your letter No. Nil dated 10-07-2020 received at this office on 20-07-2020, the reply furnished by, was examined and
 no satisfactory reply and documents/details has been furnished thus the compliance is not found observed and the violation of
 Rules 11(1), 35(2) & 55 of MCDR, 2017 still persists.

 In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.

Mining Operation can be suspended as per rule [1(2) in case of non compliance of rule 11(1) of MCDR 2017.

5. May initiate appropriate action in accordance with any competent orders/directives etc.

 You are therefore directed to show cause within a period of thirty (30) days from the date of issue of this letter, as to why you should not be prosecuted and / or why mining operation can be suspended under statutory provisions.

Please note that no further notice will be given to you in this regard
