Scrutiny comments in respect of the Modification of Mining Plan and Progressive Mine Closure Plan of Medesara Limestone mine, area 17.9 ha, lessee M/s Singhania Minerals Private Limited, in village Medesara, Tehsil Dhamdha, District -Durg, Chhattisgarh, submitted under Rule 17(3) of MCR(other than Atomic and Hydrocarbon Energy minerals) 2016 and 23 of MCDR 2017. Site inspected on 2.11.2018 by Shri J.S. Hada, Assistant Mining Geologist.

1. On cover page- Minecode, lease period from to, Plan period, modified mining plan proposal period and lessee registration no needs to be mentioned.
2. Consent Letter: Para 05: Para should be modified to include the name of 'Progressive Mine closure Plan'.
3. Consent Letter Para 06: not relevant, may be removed.
4. The experience certificate:- The rule quoted should be corrected to 55 (1)(c)(i).
5. List of Plates: Reclamation Plan has not been submitted.
6. List of annexure: Copy of lease deed with lease period extension to 50 years has not been submitted. Copy of last approved MP letter has not been submitted. Copy of the registration of the company has not been submitted.
7. At a Glance Information, page 1: supporting document for item 9 needs to be submitted. Also for Para 1.9, page 2. Mineral reserves should be as on 1.4.2018. To arrive at this figure, production from April 2018 to September 2018 should be subtracted from the figure as on 30.9.2018.
8. Para 2.3, page 3: Mine code should be corrected.
9. Para 2.14- coordinates of lease boundary pillars are given but same have not been authenticated by competent authority of state government.
10. Para 3.2, page 5: the date of approval of last mining plan should be corrected to 15.7.2016.
11. Para 4.3: The deviation as per the last violation letter should be given.
12. Para 4.17, page 6: The capacity of water tanker should be corrected.
13. Para 7.4 (vii & viii), unit may be corrected to no of holes required and then calculates in drill mtr.
14. Para 7.12.1- The adequacy of excavator deployed is on very higher side. From below table it is clear that only one machine is sufficient to meet targeted production..

16. In conceptual plan – Details for conceptual period needs to be given in this chapter leaving present proposals of mining plan.
17. Para 14.1(b)- Details are not furnished in para.
18. Para 14.3.10, page 26: The sentence should be corrected for submission of FA to RCOM Raipur and not Nagpur. The FA shall be made in favour of RCOM, IBM, Raipur.
19. Financial assurance plan:- Area considered for calculating of financial assurance in respect of excavation and overburden dump and other items have not been shown with different color as per area put to use for calculation of financial assurance table. The different areas shown in table needs to be put in figures in various blocks of plan
