Subject: Violation of provisions of Mineral Conservation & Development Rules, 2017 inrespect of your Vikram Cement Limestone Mine-III (564.106 Hect.) in Neemach district of **M.P**.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during MCDR inspection on 02/09/2021 by the undersigned in presence of Mr. Subhash Nigam (Sr. VP, Agent), Mr. Akhilesh Pratap Singh (GM, Mines), Mr. Mahesh Shrimali (Mines Manager), Mr. Ratikanta Behera (Geologist). During the inspection it was found that following provisions of rule have been violated.

नियम स.	<u>पाए गए उल्लंघन की विस्तृत प्रकृति</u>
Rule 11 (1)	According to this rule-No holder of a mining lease shall commence or carry out mining operation in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Govt. pursuant to the provisions to clause (b) of Sub Section (2) of Section 5 or approved by the competent authority of the Atomic Minerals Directorate for exploration and Researching respect of minerals specified in Part B of the First Schedule of the Act where the grade of such atomic minerals is equal to or above the threshold value limit declared under schedule-A of the Atomic Mineral Concession Rules 2016.
	The Review of Mining Plan of above mentioned mine was approved vide this office letter No- MP Neemuch/Limestone/RMP-22/19-20 dated 10/12/2019 incorporating the proposals of working from 2020-21 to 2024-25. <b>During the year 2020-21, it was proposed to generate 7300 M<sup>3</sup> top soil and 5000</b>
	tonnes overburden for mine development in eastern side of E Block. But, no mine
	development was carried out as per approved document.
Rule 63(1)	<b>Preservation of cores, etc(1)</b> Every holder of a mineral concession and every agency authorized under the second proviso to sub-section (1) of section 4 shall preserve intact, until submission of the final geological report, all cores and specimens of different types of rocks and minerals obtained during drilling or sinking operations and shall arrange for them to be laid out in a serial order with identification marks, showing the progressive depth at which, they are obtained.
	During the inspection, it was observed that the core samples of boreholes were not kept systematically.

- In this connection it is brought to your notice that the above violations constitute an offence 01. punishable under Rule 62 of MCDR-2017.
- Non-compliance of the rule 11(1) of MCDR-2017 may lead to suspension of Mining 02. operations under the provisions of rule 11(2) of MCDR-2017.
- You are advised to rectify the above violations immediately and intimate the position to this 03 office within 45 (Forty-Five) days from the date of issue of this letter.
