Sub: Violation of Provisions of MCDR, 2017 in respect of your Kamalapuram Limestone and Dolomite Mine (38APR11133) over an extent of 4.213 Ha situated in Kamalapuram Village of Dhone Mandal in Kurnool district of Andhra Pradesh State.

Sir,

The following provisions of Mineral Conservation and Development Rules 2017, were found violated in your above mine during the inspection of mine on 22/10/2021 by the undersigned accompanied by yourself.

Rule no.	Nature of violation
20	<i>Notice for opening of mine.- (1) The holder of a mining lease shall send to the authorised officer, as the case may be, an intimation in Form C of the Schedule of the opening of a mine so as to reach them within fifteen days of such opening, which shall be accompanied with a copy of the approved mining plan, in case the mine is being opened after a lapse of five years period from the date of approval of the mining plan.</i> Mine was reported to be opened in the month of July 2021, whereas notice of opening of mine has not been submitted so far to this office.
45(5)(c)(i)	<i>The holder of mining lease shall submit online returns in respect of each mine to the Regional Controller or any other authorised official of the Indian Bureau of Mines in the following manner, namely:-</i> <i>(c) An annual return which shall be submitted before the 1st day of July each year for the preceding financial year in electronic form, along with a signed print copy of the same if it is not digitally signed, in the respective Form</i> Annual return for the year 2020-21 has not been submitted so far to the Regional Controller of Mines, Indian Bureau of Mines, Hyderabad as required under this rule.
54	Production & dispatch register, mining machinery register, sale invoices, have not been found maintained at mine site for verification, as required under this rule.
55 (3)	<i>Employment of geologists and mining engineers.-</i> <i>every holder of a mining lease shall employ, in case of—</i> <i>(i) category „A“ mines having leased area equal to or above twenty-five hectares, a whole-time mining engineer and a geologist;</i> <i>(ii) category „A“ mines having lease area below twenty-five hectares and category „B“ mines, a part-time mining engineer and a part-time geologist;</i> <i>Provided that in the case of fully mechanised category „A“ mines, the mining</i>

engineers and geologist shall have minimum five years of professional experience of working in a supervisory capacity in the field of mining.”;

During inspection of mines it was observed that part time mining engineer and Geologist were not employed

02. In this connection, it is brought to your notice that continuing contraventions of the provision of these rules by submitting late returns also attracts the action as per the provision of rule 62 of MCDR, 2017. Further non compliance of rules is punishable with Fine as per schedule-III of MCDR (Amended Rules). Inability to comply the provision of rules 45(5)(c)(i) of MCDR, 2017 is also liable for suspension of Mining operations under rule 45(7)(a)(i) and other actions as per the provision of rule 45(7)(a) of MCDR 2017.
03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.


