Violation of Provisions of MCDR, 2017 in respect of your Kocheruvu Mine (38APR11138) over an extent of 6.621 Ha situated in Kocheruvu Village of Dhone Mandal in Kurnool district of Andhra Pradesh State.

Sir.

The following provisions of Mineral Conservation and Development Rules 2017, were found violated in your above mine during the inspection of mines on 20/10/2021 by the undersigned accompanied by yourself.

54	Production & dispatch register, mining machinery register, sale invoices, have not
	been found maintained at mine site for verification, as required under this rule.
55 (3)	Employment of geologists and mining engineers
	every holder of a mining lease shall employ, in case of—
	(i) category "A" mines having leased area equal to or above twenty-five hectares, a
	whole-time mining engineer and a geologist;
	(ii) category,,A" mines having lease area below twenty-five hectares and category
	"B" mines, a part-time mining engineer and a part-time geologist:
	Provided that in the case of fully mechanised category "A" mines, the mining engineers and geologist shall have minimum five years of professional experience
	of working in a supervisory capacity in the field of mining.";
	During inspection of mines it was observed that part time mining engineer and
	Geologist were not employed

02. In this connection, it is brought to your notice that the above violation constitutes an offence punishable under Rule-62 of MCDR, 2017. Further non compliance of rules 55 of MCDR 2017 is punishable with Fine as per schedule-III of MCDR (amended Rules).

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
