

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 25.11.2022 in the presence of Sri. N.Hari Prasad, DGM(Mines).

Rule No.	Nature of Violations observed
31 (4)	The plans and sections required under these rules shall be maintained up to date showing also the respective proposal of approved mining plan for various activities pertaining to that year, within three months in case of category 'A' mines as referred to in clause (a) of sub-rule of rule 55, and within twelve months in the case of any other mine.
	The respective proposal of approved mining plan for various activities pertaining to the year (2022-23) were not shown in the plans and sections maintained.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
