The following provisions of MCDR,2017 were found violated in your above mine during inspection on 23/09/2021 by Shri Sanjay Kumar Mahapatra, Assistant Mining Engineer in presence of Mine official Shri T D Behera, Mine Manager, Shri K K Sahu, Mining Engineer and Shri R R Nayak, GM (Geology).

11(1)	 Mining operations have not been carried out in accordance to the Modification of Review of Mining Plan, approved vide this office letter number MSM/OTFM/38-ORI/BHU/2018-19 dated 17.01.2019 to the extent given below: 1) During the year 2020-21, it was proposed for Back-filling of 0.645 ha in the area in between 400S TO 150 S and 300 E to 500E. However during inspection it is observed that about 0.3 ha only of area Back-filling has been achieved. 2) The terrace dimensions has not been maintained as per proposal in the Mineral Reject (Sub grade) Stack in SG Stack -1 in Raikela Block between grid 430S-500S to 400 E -510 E.
45(5)(c)	Discrepancy observed after scrutiny of Annual return for the for the year 2020-21 are as follow: (i) In the Annual Return submitted for the year 2020-21 the information furnished in Part- VII regarding production proposal for the year 2020-21 has been wrongly furnished.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of Mineral Conservation and Development Rules, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory and may recommended for suspension/termination of mining lease under rule 45(7)(a), if rule 45(5)(c) are not complied.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
