
The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the inspection on 20.10.2021 by the undersigned in the presence of Shri. P.Jani Reddy, Agent & Shri. P.S Murthy,Q.P.

Rule No.	Nature of Violations observed
26(2)	<p><i>The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof:</i></p> <p>Yearly report setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved progressive mine closure plan is not submitted to Regional Controller of Mines for the year 2020-21.</p>
55 (3)	<p><i>Employment of geologists and mining engineers.- every holder of a mining lease shall employ, in case of—</i></p> <p>(i) category „A“ mines having leased area equal to or above twenty-five hectares, a whole-time mining engineer and a geologist;</p> <p>(ii) category „A“ mines having lease area below twenty-five hectares and category „B“ mines, a part-time mining engineer and a part-time geologist:</p> <p><i>Provided that in the case of fully mechanised category „A“ mines, the mining engineers and geologist shall have minimum five years of professional experience of working in a supervisory capacity in the field of mining.”;</i></p> <p>During inspection of mines it was observed that whole time mining engineer and Geologist were not employed.</p>

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.




