Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of Gandarai Iron Ore Mine of M/s Sri Lakshmi Enterprises over an extent of 9.268 ha situated in Gandarai Village, Jaggayyapeta Mandal, Krishna District of Andhra Pradesh State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during inspection of the mine on 03.11.2021 by the undersigned accompanied by yourself.

26(2)	<p><i>The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof:</i></p> <p>Yearly report setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan is not submitted to Regional Controller of Mines for the year 2020-21.</p>
31(4)	<p><i>The plans and sections required under these rules shall be maintained up to date within three months in case of category 'A' mines as referred to in clause (a) of sub rule (2) of rule 55, and within twelve months in the case of any other mine.</i></p> <p>Plans and sections have not been maintained updated, the plans was last updated on 20/09/2018</p>
45 (5) (7)	<p>Discrepancies are observed in the Annual returns submitted for the year 2020-21 as below:</p> <p>Refer Part-V, section-3, details of reserves and resources is not furnished Refer Part-V, item 4.2 (B)Details of ROM ore production, item no. 4.2 C- Waste generation, 4.2 C(i), Quantity backfilled is not furnished In part-VII, 5. Sales/Dispatches. Registration no. allotted by IBM to the buyers are not furnished Part-I.</p>






