In this regard, you are directed to submit the Financial Assurance in the form of Bank Guarantee for the area put on use for Mining and allied activities @ Rs.Three lakhs/hectare for category 'A' mines provided that the minimum amount shall be Rs.Ten lakhs as per the provision of Rule 27(1) of MCDR, 2017 at the time of submission of final copies of the document within 15 (fifteen) days from the date of issue of this letter, failing which the document will be disposed without giving any further opportunity.
- 03. The para-wise clarification & the manner in which the deficiencies are attended should be given while forwarding modified document.

Table scrutiny comments on Review of Mining Plan of Tummalapenta Limestone Mine-3 of M/s. Ultratech Cements Ltd. over an area of 90.52 hectares in Tummalapenta village, Kolimigundla Mandal, Kurnool District, Andhra Pradesh.

General

- 1. Mine code be mentioned in the cover page.
- 2. Consent letter/undertaking/certification by the applicant shall be on Company's original letter head duly signed with date.
- 3. Approved and proposed production of all the mining leases linked to the plant and their approved EC quantity shall be submitted.
- 4. In page no.5 the EC details shall be submitted correctly.
- 5. The contact details like mobile number, email id of the Nominated Owner be mentioned in page no.8.
- 6. The annexure numbers shall be mentioned correctly in the document submitted.
- 7. The list of annexures to mentioned in the volume-1(annexures).
- 8. Limestone consumption factor report shall be submitted for line-1 and line-2, accordingly the limestone requirement shall be submitted.
- 9. Color photographs should be enclosed in the document for easy reference pertaining to boundary pillars, working pit, dump, afforestation, core logs, ground control points etc.
- 10. The boundary pillar surveyed using DGPS for its ground position authenticated by State Government shall be submitted.
- 11. Reason for modification in the approved mining plan be submitted with due justification.

Review of Mining plan

- 12. Proper justification for deviation in the proposed development, production and afforestation shall be submitted.
- 13. Status of compliance of violations pointed out by IBM shall be submitted.

Geology and Exploration

- 14. In page no.23 the limestone type shall be mentioned correctly.
- 15. Levels of exploration (G1&G2) carried out and its area shall be discussed in the exploration chapter and to be clearly shown over Surface Geological Plan.
- 16. In page no.25, borehole drilled year to be mentioned in the table of borehole drilled details.
- 17. Exploration shall be proposed and carried out for the entire mineralized area and till the contact zone under the mining lease.
- 18. Exploration proposed year shall be submitted in page no.28.
- 19. The required quality of limestone for plant feed shall be submitted.
- 20. The classification of Reserves and Resources with average grade of Cao, MgO & SiO₂ shall be submitted.
- 21. Reserves and resources to be estimated as per MEMC rules,2015.
- 22. Feasibility report study report along with financial analysis for economic viability of the deposit as specified under the MEMC rules, 2015 field guidelines shall be submitted.

Mining

- 23. Co-ordinates of the pit proposed to be worked in the plan period be submitted.
- 24. Specifications & details of the machineries like model, imported/exported, digging height etc., shall be submitted.
- 25. Blast vibration monitoring details as per DGMS (A) & (B) standards be submitted.

Conceptual plan

- 26. Annual production capacity for which the mine is planned and designed to be mentioned explicitly. The time schedule by which the mine will attain its designed capacity has to be submitted.
- 27. Proposed production quantity for the conceptual phases till the end of reserves/mine life be submitted with due justification.
- 28. Life of the mine based on the proposed production/mine capacity be submitted correctly.
- 29. Area utilization, location and species to be planted shall be submitted for the conceptual period.
- 30. Reclamation and rehabilitation measures for soil dumps shall be submitted.
- 31. Conceptual land use pattern for the plan period and till the mine life be submitted.

Mine Drainage

- 32. Quantity and quality of water likely to be encountered in the mining area, pumping arrangements and its discharge proposal shall be submitted.
- 33. Location of the sump proposal with co-ordinates and sump capacity holding the water encountered into the pit shall be submitted.
- 34. Water quantity required for mining use, dust suppression, plantation etc., and its mode of usage shall be submitted.
- 35. Hydro geological study report, if any, shall be submitted.

Stacking of Mineral Reject/Sub-grade material and waste disposal

- 36. Top soil dump proposal shall be submitted for the quantity generated during the plan period
- 37. Proposal for protective measures of the soil dumps shall be submitted.

Processing of ROM and Mineral reject

38. Location of the crusher be mentioned in the text part and to be marked on the relevant plan.

Others

- 39. The location of the list of site services be submitted and also to be marked in the plans.
- 40. Deployment of surveyor as per statute to be mentioned in the employment potential.

Progressive Mine Closure Plan:

- 41. Top soil management shall be mentioned correctly in page no.86.
- 42. Year wise protective measures for reclamation and rehabilitation works for the plan period be submitted as per the table mentioned in IBM manual of appraisal 2014.
- 43. Proposed year and location of the garland drain to be mentioned in text and marked on the relevant plan.

Plans and Sections:

- 44. Boundary pillars to be mentioned in the plans submitted.
- 45. Surface control points shall be mentioned in the plans.
- 46. In the geological section the borehole details like depth of borehole, RL's of the borehole collars shall be mentioned.
- 47. All the features in the plans and sections shall be mentioned correctly in the index.

- 48. As per Rule 34 of MCDR, every plan, section or part thereof under these rules shall carry thereon a certificate for its correctness and shall be signed by the Mining engineer with date. Provided that the geological plans and sections shall be certified and signed by the geologist employed under rule 55.
- 49. Conceptual plan shall be re-submitted showing conceptual size of the pit, afforestation, land use pattern at the end of this 5 year period and at the end of lease period.
- 50. Proposals shall be submitted in .kml or.shp files in the form of soft copies.
