Sub: Violation of provisions of MCDR, 2017 in respect of Jayanthipuram Limestone Mine(South Band) over an area of 88.35 ha in Jayanthipuram Village, Krishna District, Andhra Pradesh.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 03.12.2021 by the undersigned accompanied by Sri P.Jani Reddy, Agent(Mines).

Rule No-	Nature of violation
11 (1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section(2) of section 5. "It was proposed to rehandle the Sub-Grade ore dump while maintaining the height not more than 9 meters. However, during the inspection it was observed that height is more than the proposed height".

- 02. In this connection, it is brought to your notice that the above said violations constitute an offence punishable under Rule-62 of MCDR, 2017. Further, inability to comply the provision of Rule 11(1) is liable for suspension of mining operations under Rule 11(2) of MCDR,2017.
- O3. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
