Chandrasekhar Reddy, Assistant Mining Engineer, accompanied by Sri M.R. Rajaranjith Singh, Dy. General Manager (Mines) & Manager and Sri B.Radhakrishnakanth, Manager.



11(1)	<p>Mining operations have not been carried out in accordance with the modification to the Approved Mining Plan approved vide letter no. TN/TCR/LST/ROMP/1443.MDS dated 10.11.2017 to the extend indicated below:-</p> <p>(1) There was a proposal in the approved ROMP to produce Limestone 24508 tons in the year 2021-22, against that 36700 tonnes of Limestone was produced, which is on higher side of the approved quantity.</p> <p>(2) There was a proposal in the approved ROMP to produce 65662 tonnes of marl during the year 2021-22, whereas '0' marl was produced in 2021-22.</p>

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under Rule 11(2) and or prosecution can be launched if the compliance of Rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.


