The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 22/11/2019 by the undersigned, accompanied by Sri V.Balasubramani, Mines Manager and Shri. Rami Reddy, Mining Engineer.

Rule No.	Violations observed
11(1)	(1) Modification & Review of Mining Plan was approved vide letter no. 279/1044/2009/BNG dated 02/08/2017 for the period of two years with a production proposals of 9.9 Million tones for the year 2018-19. The RMP was approved vide letter no. 279/1044/2009/BNG dated 20/11/2018 with production proposals of 4.0 Million tones for the year 2019-20. The deviations observed in mining operations vis-à-vis approved documents are given below.
	 (i) During the year 2018-19, 2.837 Million tones of production is achieved against the proposal of 9.9 Million tones. Deviation is -71%. (ii) During the year 2019-20 till date 1.45 Million tones of production is achieved against the proposal of 4.0 Million tones. Deviation -62% (iii) Above deviation resulted in proportionate deviation in development and other allied activities activity too.
	(2) During the year 2018-19, exploration proposals by 20 Core holes for 1000 mtrs are made but proposed exploration is not yet completed,

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
