Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 21/11/2019 by the undersigned, accompanied by Sri Debi Prasad Mukhopadhyay, Mines Manager and Shri. Ravikant Shukla Sr. Manager.

Rule No.	Violations observed
11(1)	 (1) Modification to Review and updation of Mining Plan was approved vide letter no. 279/127/89/BNG dated 04/06/2018 with a production proposals of 9.0 Million tones for the year 2018-19. The deviations observed in mining operations vis-à-vis approved documents are given below. (i) During the year 2018-19, 7.35 Million tones of production is achieved against the proposal of 9.0 Million tones. Deviation is -20%. (ii) Above deviation has resulted in proportionate deviation in development and other allied activities too.
37(5)	During the site Inspection it was observed that waste dumps are not properly stabilized through vegetation or otherwise.
45(7)	The Monthly and Annual returns for the period from April 2018 to March 2019 has been scrutinized and following deficiency observed. (i) Part VI: The total of the production reported in the monthly returns from April 2018 to March 2019(7271180MT) do not tally with the production reported in the Annual return for 2018-19.(7346120MT) (ii) Para VII: The Production proposal as per the approved mining plan has not been updated and hence it is shown as zero.

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.

O3. You are advised to rectify/explain the valid reasons for the above violation immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
