The following provisions of Mineral Conservation and Development Rules 1988, were found violated in your above mine during inspection on 23.10.2016 by Smt. Ch.Suseela, Assistant Mining Geologist., IBM accompanied by Yourself and Shri. Naresh Kumar, Geologist.

Rule no.	Rule position	Nature of violation
23 E(2)	The owner, agent, manager or mining engineer shall submit to the Regional Controller of Mines <del>or the officer authorised by the State Government in this behalf, as the case may be,</del> a yearly report before 1st July of every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof.	The yearly report for the year 2015-16 setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved scheme of Mining has not been submitted to the Regional Controller of Mines, Indian Bureau of Mines, Hyderabad.

02. It is brought to your notice that the above said violations constitute an offence punishable under Rule-58 of MCDR, 1988.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
