The following provisions of Mineral Conservation and Development Rules 2017 (MCDR, 2017), were found violated in your above mine during the inspection of the mine on 15.07.2017 by the undersigned and accompanied by yourself and Shri Mohammed Nimar, Dy. Manager(Mines) of your mine.

55(3)	every holder of a mining lease shall employ, in case of- (iii) category 'A' mines, a whole-time mining engineer and a geologist; Provided that in the case of fully mechanised category 'A' mines, the mining engineers and geologists shall have minimum five years of professional experience of working in a supervisory capacity in the field of mining:	The mine being Category-A fully mechanised mine, A whole time Geologist with five years of professional experience of working in a supervisory capacity in the field of mining has not been employed.

02. Further, please refer this office letter dated 02.03.2017 and 04.04.2017, wherein the violation of rule 11(1) of MCDR, 2017 (rule 13(1) of MCDR, 1988), is still exist in your mine.
03. In this connection, it is brought to your notice that the above violation constitutes an offence punishable under rule 62 of MCDR, 2017, further the mining operations can be suspended under rule 11(2) of MCDR, 2017, if compliance of rules 11(1) is not found satisfactory.
04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
