Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of Amtipani Bauxite Mine, over an extent of 26.30 hectares situated in Amtipani Village, Bishunpur Taluk, Gumla District, Jharkhand State - Reg.

Sir,

Undersigned inspected your above mine on 10.08.2021 along with Shri. Raghvendra Kumar, AME, IBM, Ranchi in presence of the mine officials Shri.Vishal Mahendru (Lessee), Shri.Atanu Gupta (Geologist) and Shri.Sanjay Gupta (Mines Foreman) and Violation letter of even number BIH/GML/BX/215/RRO dated 17/09/2021 was issued for below mentioned rules of Mineral Conservation & Development Rules, 2017.

Rule No.	Nature of Violations observed
11(1)	The mining operations in the Lease area are not carried out as per the last approved Review
	of mining plan.
	 a) During inspection, it has noticed that boundary pillars are not erect as per DGPS map enclosed in approved plan.
	b) As per approved surface plan, Dump-1 with dimension of 35m x 45m x 3m was present nearer to Boundary Pillar-1, whereas during inspection it has noticed that no such dump has been present and entire area is barren.
	c) It is proposed in page-39 to work within the Grid line of E-221400 during 2020-2021 & 2021-2022. But during inspection it has noticed that working is going beyond the proposed Grid line and nearer to Section line Y2 & Boundary Pillar-4.
	d) It is proposed to backfill the Quarry-3 from Western side during 2020-2021 & 2021 2022. But as per proposal backfill has not taken.
	e) There is no proposal to form a new dump during 2020-2021 & 2021-22, whereas against that new dumping has formed opposite to Dump-2 on the Jungle Jhari land.
	f) There is no proposal to backfill the Quarry-1, 2 & 4 during 2020-2021 & 2021-22 against that it has been backfilled and afforested.
	g) It is proposed in page-62 to afforest 250 saplings during 2020-2021 within 7.5n safety barrier on the Northern side of Lease area, against which no saplings have been planted on the proposed area.
	h) During inspection it has noticed that Quarry-5 has worked in 7.5m safety barrier of Eastern side from Boundary Pillar-13 to 16. Same has been shown in high resolution Satellite map submitted to this office on 29.07.2021.

31(4)	The plan and sections are not updated in last three months, as required under the rule and last date of survey has taken on 10.04.2020.
33	The plans & sections prepared under Rule 32 for the year 2020-21 have not been submitted to this office.
45(7)	 The following discrepancy has been observed for the Annual Return 2020-2021, Part-V:- Reserves & Resources are not updated and show same value of the approved plan. Even though 47835 tons of production is there but same has not been depleted from the Reserves & Resources. As per approved plan and Submitted NABL test result shows 80% Recovery whereas in all the annual returns and monthly returns shows 100% Recovery from ROM.

- 2. Your reply vide letter No. BNM/57/2021-22 dated 30/10/2021 received in this office on 02.11.2021 has been considered. After examination it has been seen that, reply given for compliance of Rule 33 of MCDR 2017 is satisfactory. However, it has been found that even after lapse of 45 (Forty Five) days from the issue of violation letter, the violations for the Rule 11(1). 31(4) & 45(7) of MCDR-2017, remain to be continued and rectified.
- 3. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.
- 4. The Mining operations can be suspended under Rule 11(2), if compliance of Rule 11(1) is not found satisfactory.
- 5. You are therefore, directed to show cause within a period of 30 (Thirty) days as to why you should not be prosecuted for the above offence and/or why mining operations shall not be suspended as per provision of MCDR, 2017.
- 6. Please note that no further notice will be given to you in this regard.
