SCRUTINY COMMENTS ON THE REVIEW OF MINING PLAN SUBMITTED UNDER RULE 17(2) OF MCR,2016 FOR D.GADABAVALASA MANGANESE MINE OF M/S BLUE OCEAN MINERALS PVT. LIMITED IN D.GADABAVALASA VILLAGE, THERLAM MANDAL, VIZIANAGARAM DISTRICT, A.P.

Text:

1. **Para 2.2.1.5** – Pitting: It is mentioned that seven pits were made, however, the details of pits are not mentioned in the relevant table.
2. **Para 2.2.1.6** - Trenching: It is mentioned that three trenches were made, however, the details of trenches carried out is not mentioned in the relevant table.
3. **Para 2.2.4.7** – Cost & revenue factors: The cost of production is reported as Rs.2200/- per tonne. However as per the Annual return 2020-21, the cost of production reported was Rs.2965/- per tonne. This needs to be corrected.
4. **Para 3.5.2** – Other operations: During the inspection it was observed that manual sizing and sorting of the ore being carried out. The details of the same to be mentioned in the relevant table under the said heading.
5. **Paras 4.1.1 & 4.1.2** – Existing and proposed method of mining i.e. either Mechanized or Manual need to be mentioned.
6. **Para 4.2.2.3** – Transportation & Hauling equipment: No information about Hauling equipment mentioned in the relevant table.
7. **Para 5.3:** - Rehabilitation & Resettlement of affected persons: The justification for arriving at a number of 12 persons per year as project affected persons (PAP) during the next five years need to be mentioned.
8. **Para 6.2.2.2.2:-Retaining wall:** As a new dump is proposed for next five year block period, details of retaining wall are to be incorporated.
9. **Para 6.2.3.2-Year wise proposal-** During the inspection it was observed that an area about 1.5 ha is undisturbed accordingly, the year-wise proposal for afforestation to be proposed.
10. **Para 7.2** – Financial Assurance – The amount mentioned in the column needs to be submitted as Financial assurance along with final copies. The date of validity to be filled in the table.
11. In the present block period, Slope stability study to be proposed and the recommendations made there under to be incorporated for systematic development of mine benches.

13. The annexure pertaining to permission accorded for working in the barrier zone not legible, a legible copy to be enclosed.
14. All the Annexures to be properly numbered.

15. Predominant wind direction to be marked in key plan. *and Environment Plan.*
16. The authenticated lease sketch by State Government submitted in hard and soft is not legible, submit a legible plan.
17. In the surface plan, signature of surveyor to be incorporated.
18. In all the production and development plans, year-wise development with distinct color code and year on the plan to be mentioned. The same to be included in Index.
19. In the conceptual plan, proposed reclamation and rehabilitation measures at the end of the life of the mine are not shown.
20. In the progressive Mine closure plan, area put to use table to be incorporated.
21. In the surface Geological Plan, Waste dump with proper color code to shown in index.
22. Geological Sections:
 - (a) In the Section A3-A3' & A4-A4' lateral extent is not matching with the Geological plan.
 - (b) In the Geological Plan, section A5-A5' was shown, however, the same not shown in the Geological sections.
 - (c) The section F-F' not shown on Geological plan but shown in Geological section. Please clarify.
 - (d) The 7.5 meter barrier zone to be marked in all the Geological sections.
 - (e) The same to be shown in the index also.
23. The .kml files submitted are to be correlated with the plans furnished along with proposals with detailed nomenclature/attribute data.
24. In all the plans, block period of Review of Mining Plan to be mentioned.
