In this regard, you are also advised to submit the Financial Assurance in the form of Bank Guarantee for the area put on use for Mining and allied activities @ Rs.Five lakhs/hectare for category 'A' mines provided that the minimum amount shall be Rs.Ten lakhs as per the provision of Rule 27(1) of MCDR, 2017 at the time of submission of final copies of the document within 15 (fifteen) days from the date of issue of this letter, failing which the document will be disposed without giving any further opportunity.

- 2. Para 1.2 Details of the Khasara nos. of the mining lease should be submitted.
- 3. Para 1.3.4.2, details of approval obtained by SPCB should be furnished
- 4. Para 1.3.4.4, details of land acquisition shall be furnished.
- 5. Para 1.3.5.1, details of coordinates of lease boundary pillars based on DGS survey authenticated by State Government should be furnished.

## **GEOLOGY & EXPLORATION**

- 6. Para 2.1.2, details of villages, river, nala, public road, cart road, railway line should be furnished.
- 7. Para 2.1.2 & para 2.1, 4.7 details of litholog within the lease area should be furnished considering the exploration carried out and exposure in the pit.
- 8. Para 2.1.4.4, details of mineral description of all litho units occurred in the lease area shall be furnished.
- 9. Para 2.2.1.9 & para 2.2.1.10, details of sampling and chemical analysis of exploration carried out in the last period should be furnished.
- 10. Para 2.2.2.9 & Para 2.2.2.10, details of sampling and chemical analysis of exploration carried out during before last plan period should be furnished.
- 11. Para 2.2.2.13, stud carried out for assessing bulk density should be enclosed as annexure.
- 12. Para 2.2.4.2, resources in the potential mineralize area should be assessed and submitted.
- 13. Para 2.2.4.4 to 2.2.4.9, factors considered for conversion of Resources to Reserves should be furnished specific to the mine.
- 14. The bore hole analysis report shall be authenticated by the statutory Geologist overseen the exploration activity

Chapter 6: Progressive Mine Closure Plan:

15. Proposals of protective measures like fencing of Pit, Garland Drain shall be submitted.

- 16. Surface Plan:
  - a) Date of survey be mentioned
- 17. Geological Sections:
  - a) UPL, HFL line, Nala, Village, Railway line to be marked properly.
- 18. Year-wise production & development plan:
  - a) Plans and Section should be submitted in 1 in 2000 scale for clarity.
- 19. Color photographs should be enclosed as annexure for easy reference pertaining to Lease Boundary Pillars, Working Pits, Core logs, Afforestation, Ground Control Points
- 20. The final document shall adhere to the conditions stipulated in CCOM circular 1/2021 & FAQ on format of Mining Plan issued vide CCOM circular no.1/2021 dated 08.09.2021.

In view of the above comments relevant para, plans and sections shall be suitably modified.
