

Violation of provisions of Mineral Conservation and Development Rules, 1988 (MCDR, 1988) in respect of Malda Manganese Mine M/s Tata Steel Ltd., in Sundargarh District of Odisha State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in respect of your above said mine during inspection on 09.08.2015 by the undersigned accompanied by yourself and Shri Tarun Chakravarthy, Geologist of your mine.

Rule No.	Position of Rule	Nature of Violation
13(1)	Every holder of a mining lease shall carry out mining operations in accordance with the approved mining plan with such conditions-as may have been prescribed under sub-rule (2) of rule 9 or with such modifications, if any, as permitted under rule 10 or the mining plan or scheme approved under rule 11 or 12 as the case may be-	Mining operations are not being carried out in accordance with the approved Scheme of Mining vide letter no. MS/OTFM/33-04/BHU/2014-15 dated 06.04.2015 to the extent indicated below:- 1. In para. 4.0, page 104, It was approved to provide drains and bundhs (stonewalls) around the dumps to arrest wash off of the material dumped; against which in Block-III of the lease area, garland drain and stone wall around waste dump has not been provided



effectively resulting formation of gullies and wash off of dumped material degrading low lying area.

- 2. In para. 4.0, page 104, it was approved to carryout concurrent reclamation of dumps: against which area matured for reclamation in the waste dump yard in Block III area of the lease has not been carried out.
- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 58 of MCDR. Inability to comply the provision of rule 13(1) of the MCDR, 1988, is liable to suspension of all mining operations in the mine under the provisions of rule 13(2) of MCDR, 1988.
- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
