The following provisions of Mineral Conservation and Development Rules 1988 (MCDR, 1988), were found violated in your above mine during the inspection of the mine on 23.09.2016 by the undersigned and accompanied by Sri B S P Raju, Agent, Sri Jani Reddy, Manager (Mines), Sri P S Murthy, Geologist, of your mine.
