The para- wise clarification indicating the manner in which the deficiencies have been attended should invariably be given while submitting the Review of Mining Plan. No further extension of time in this regard will be entertained and the document will be considered for rejection if not submitted within the above due date and deficiencies not attended properly. Scrutiny Comments on Draft Review Mining Plan with Progressive Mine Closure Plan of Umsoo Mootang Block-I Mines over an area of 4.90 Ha. in village Thangskai, Taluka-Khliehriat, Dist- East Jaintai Hills, Meghalaya of M/s. Dalmia Cement (Bharat) Limited, prepared by Sri Sanjay Kumar (Qualified Person) under Rule 17 (2) of MCR 2016 & 23 of MCDR 2017.

## **TEXT**

- 1.0 Mining plan needs to be prepared & submitted as per the new and updated prescribed format given in "IBM manual for appraisal of Mining Plan 2017. The submitted document does not contain, "Summary of proposals at a glance" information of proposals as per the IBM manual, needs to be furnished.
- 2.0 The period of the review of mining plan is a block of five years. In the submitted document, both block period and proposal period of the review of mining plan needs to be furnished.
- 3.0 In the introduction chapter a brief history of the mining lease to be given depicting all the statutory clearances/ court cases (if any) etc. with documentary evidence from the grant of the mining lease to as on date in chronological order.
- 4.0 Under introduction chapter (page no-2), it has been mentioned that photographs of boundary pillars are attached as Annexure-15, which are obscure.
- 5.0 Under 2.8; copy of educational qualification and professional experience of the qualified person needs to be furnished.
- 6.0 Information furnished under 3.11 & 3.14 need to be furnished properly.
- 7.0 Information furnished under 6.5 (page no-27, 28 &29) are not matching with geological plan and sections of the submitted document and the same needs to be rectified in both text and plates.
- 8.0 A fresh re-assessment of the resources/ reserves needs to be carried out as per the extant provision given in 'Mineral (Evidence of Mineral Contents) Rules 2015'. The section lines taken for resource/reserve calculation through Surpac in page no-27, 28 & 29 are not shown in the geological plan and sections. Neither these sections are shown in the year-wise development plan and sections. Accordingly level wise & section wise resource/ reserve figures to be reported and categorisation of resources/ reserves as per the UNFC system needs to be furnished.
- 9.0 Back up calculation along with grade for blocked resources under various modifying factors needs to be provided either in feasibility study report or in text or in both.
- 10.0 The life of the mine needs to be calculated with the average quantity of the total quantity of the proposed production.
- 11.0 The details furnished in reclamation and rehabilitation & post mining land use conceptualised need to be recast. (7.25 to 7.26).
- 12.0 The details of mode of disposal of surface run-off water shall be discussed indicating the schematic route showing its discharge with proposed provisions of check dams/ settling tanks (if any)/ water quality monitoring stations etc. The proposal shall also to be shown in the reclamation plan.
- 13.0 Under employment potential chapter, existing and proposed to employ under different categories needs to be furnished in two different columns.
- 14.0 Information on protective measures for reclamation and rehabilitation works (yearwise) needs to be furnished under 14.3.7.

- 15.0 Information furnished under 14.3.13, financial assurance details is not clear. The submitted bank guarantee is valid till 09.06.2021, where as validity of review of mining plan is five years, i.e. 2019-20 to 2023-24. The financial assurance should be co-terminus with the plan period i.e. up-to 2023-24.
- 16.0 Estimated resources/ reserves as per the UNFC system needs to be reported in feasibility report (Annexure-14).
- 17.0 Original copy of Consent letter/Undertaking/Certificates needs to be furnished.
- 18.0 Some of the annexure are obscure. Legible copy of annexure needs to be submitted.
- 19.0 Copy of the surveyor's certificate to be enclosed who has conducted the topographical survey of the lease area.

## **PLATES:**

# 1.0 Key plan:

- 1.1 Key plan shall be prepared strictly as per the extant provisions specified under rule 32(5)(a) of MCDR 2017.
- 1.2 Location of the lease area is not matching with the reference of authenticated lease map.
- 1.3 Monitoring station needs to be shown in both core and buffer zone.

## 2.0 Legible copy of Authenticated lease plan needs to be furnished.

2.1 As per CCOM circular No 2/2010, a geo-referenced lease map authenticated by the competent authority needs to be submitted.

## 3.0 Surface plan:

- 3.1 Surface plan is not matching with the boundary description furnished in authenticated lease map. Details of field reference point furnished in surface plan is not matching with the reference furnished in the authenticated lease map of the submitted document.
- 3.2 All existing features needs to be shown in the surface plan with proper index.

## 4.0 Geological plan/ sections:

- 4.1 Surface features of geological plan is not matching with the surface plan of the submitted document.
- 4.2 Geological litho units and features needs to be shown in plan and sections.
- 4.3 Ultimate pit limit needs to be shown in both geological plan and sections.
- 4.4 UNFC codes has not shown in the plan and sections needs to be furnished. Colour codes of feature shown in plate and index are not matching needs to be corrected.

# 5.0 Mine development/ production plan & sections/ dump plans & sections/ conceptual plan/ sections:

- 5.1 Geological litho needs to be shown in all year-wise development plan and sections.
- 5.2 Ultimate pit limit needs to be shown in all year-wise development plan and sections.
- 5.3 Year-wise development, plantation and other programmes needs to be shown in different colour codes.
- 5.4 Conceptual plan and section needs to be furnished as per the revised proposal of conceptual period.

### 6.0 Environment plan:

- 6.1 Environment plan shall be prepared strictly as per the extant provisions specified under rule 32(5) (b) of MCDR 2017.
- 6.2 All existing surface features to be shown in the environment plan.
- 6.3 Existing afforestation & reclamation carried out, if any, shall be shown.
- 6.4 60 mtr radius boundary along with existing features needs to be furnished.

## 7.0 Reclamation plan/ sections:

- 7.1 The proposed plantation & reclamation shall be indicated in a tabular form indicating the proposed year of carrying out the above said activity/ area to be covered (ha.)/ no. of saplings to be planted/ species of saplings to be planted along with location of the activity. The table should be given separately for reclamation & afforestation program proposed.
- 7.2 Proposed bench / dump position at the end of review of mining plan period to be shown with points of monitoring of AAQ parameters.
- 7.3 Existing bench also to be shown in a lighter shade.
- 7.4 The water management plan showing the position of garland drains/ retaining walls/ check dams/ settling pits if any, should be clearly indicated in this plan.
- 7.5 Proposed reclamation program for the review of mining plan period needs to be shown.

# 8.0 Financial assurance plan:

- 8.1 The existing/ proposed usages under different categories shall be coded in different colours with specific boundaries and reported in index.
- 8.2 Financial assurance table needs to be inserted in the plan.
