The following provisions of Mineral Conservation & Development Rules, 1988 (hereinafter referred MCDR, 1988) were found violated in your above said mine during inspection on 04.08.2015 by undersigned accompanied by Shri Khitish Sah (Sr. Mining Inspector, Koira Circle), Shri T.C. Sei (Agent and GM Mines), Shri H.K. Sahoo (Mine Manager) and Shri Ashutosh Mahapatra (Geologist).

24(1)	(1) The owner, agent, mining engineer or manager of every mine shall send to Controller General, Controller of Mines and the Regional Controller of Mines a notice in Form D-1.....such temporary discontinuance.	1) During inspection it was observed that Mine was under suspension since April 2012. However, Notice for temporary discontinuance of mine in form D-1 has not been submitted to Regional Controller of Mines, Bhubaneswar.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 58 of MCDR, 1988.

03. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter
