Sub: Violation of provisions of MCDR 1988 in respect of your Salaiya Limestone Mine over an extent of 459.566 hect in district Satna of Madhya Pradesh.

The lease deed has been executed on 6.03.2012 in favor of M/s ADA Enterprises & Ventures Pvt. Limited. The State government vide letter no. nil dated 28.08.2015 endorsed the change in the name of M/s ADA Enterprises & Ventures Pvt. Limited to M/s Reliance Ornatus Enterprises and Ventures Private limited

The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection by the undersigned on 3.10.2016 in presence of Shri Shailendra Jain (Mines Manager).

Rule No.	Nature of violation observed
<b>23E</b>	(2) The owner, agent , manager or mining engineer shall submit to the Regional Controller of Mines or the officer authorized by the State Government in this behalf, as the case may be, a yearly report before 1 <sup>st</sup> July of every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure Plan, and if there is any deviation, reasons thereof. <i>The notice of opening of mine was submitted on 1.12.2014 in form C. The yearly report for the year 2014-15 &amp;2015-16 in respect of rule 23E (2) of MCDR 1988 has not been submitted at this office.</i>

02. It is brought to your notice that the above said violations constitute an offence punishable under Rule-58 of MCDR, 1988.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.

04. Please note that no further notice will be given to you in this regard.
