Scrutiny comments in respect of Karlam Manganese Ore Mine of M/S.S.K.Sarwagi & Co.Pvt Ltd. over an extent of 17.63 ha in Karlam Village, Chipurupalli Mandal, Vizianagaram dist., A.P. submitted under Rule 17(2) of MCR, 2016.

Chapter 1: General Information

1. Para 1.1 : Lease Details: The details of Type of Lessee, Nature of Use, Five Year Block (Financial Year) are not furnished. Further, the mining lease is in Vizianagaram district, however, it is mentioned that it is situated In Visakhapatnam district. The same to be corrected.
2. para 1.1.1: The Lease registration date is not mentioned. The same may be furnished.
3. para 1.3.1: The details of Approval of earlier Mining Plans in Chronological Order are not furnished properly. The same may be furnished in Chronological Order.
4. para 1.3.4.2: The date of validity of SPCB Approvals may be furnished correctly.
5. para 1.3.6: The complete address of Owner may be furnished.

Chapter 2: Geology & Exploration

6. para 2.1.1: The Average Level (m) from MSL is wrongly mentioned . The same may be corrected.
7. para 2.2.1.1: The details of Geological Mapping are furnished. But the year is not mentioned, the same be furnished.
8. para 2.2.1. 7. The columns in the table to be correctly filled. The values are not matching with the column heads.
9. Para 2.2.3: The details of Dip Of Mineral Body is mentioned. The same may be mentioned.
10. Para no. 2.2.4.2: The depth to be mentioned in the table.
11. Para 2.2.4.4: The threshold and cut off values are not mentioned.
12. para 2.2.5.5 No of bore holes 30,20, and Total meterage 900 m, 780 m has given but these are proposed or already carried out to be clearly mentioned.

PLANS AND SECTIONS

13. The relevant plans and sections should be signed with date by certified Surveyor, qualified person, mines manager ,mining engineer and Geologist as per provision of Rule 34 of MCDR, 2017.
14. Key Plan to be submitted.
15. In plate no 7 i.e. Environment plan, wind direction and North direction to be given.
16. In all the production and development plans, year-wise development with distinct color code and year on the plan to be mentioned, the same to be included in Index.
17. The .kml files submitted are to be correlated with the plans furnished along with proposals with detailed nomenclature/attribute data.
18. In all the plans, block period of Review of Mining Plan to be mentioned.
19. Ground control point to be marked on the surface plan.
20. In Plate nos. V (A), V (B), V (C), V (D), V (E), and Viii (A) Modification of Mining plan to be corrected as Review of Mining plan.
21. All the plans and sections to be submitted in both hard and soft copies at the time of submission of final copies.
