Scrutiny comments on examination of Review of Mining Plan of Racherla Limestone Mine (ML-2) over an area of 17.82 Ha in Racherla Village, Peapully Mandal, Kurnool District, Andhra Pradesh submitted under Rule 17 (2) of MCR 2016.

General

1. Mine code, IBM registration number shall be submitted in the cover page
2. Excel sheet is submitted without entering/editing the details of your mine and review of mining plan submission.
3. The document shall be submitted as per the format mentioned in the FAQ on format of Mining Plans issued vide CCOM Circular 1/2021 dated 08.09.2021.
4. The final document shall adhere the conditions stipulated in CCOM circular No. 01/2021 dated 07.06.2021 & FAQ on format of Mining Plans issued vide CCOM Circular 1/2021 dated 08.09.2021.
5. Color photographs should be enclosed as annexure for easy reference pertaining to boundary pillars, working pit, dump, afforestation, core logs, ground control points etc.
6. It is proposed to carry out development and production in a common mine boundary area permitted by DGMS. Copy of permission obtained from DGMS w.r.t common mine boundary working shall be submitted.
7. The lease area submitted in the draft document is different from the original area as per the lease deed. As per original lease deed area is 17.82 Ha whereas after DGPS survey it has arrived to 18.208 Ha. Hence GO errata needs to be submitted.

Chapter 1: General Information

1.1.2 Mining Plan submission criteria details

Type of document submitted shall be submitted correctly.

1.3.5.1. Location of Boundary Pillars

Boundary pillar co-ordinates shall be submitted in UTM co-ordinates as annexure.

1.3.6. Owner/Nominated Details

As mentioned in the Mining Plan format, PAN, mobile number, email of the Nominated owner shall be submitted.

Chapter 2: Geology & Exploration

2.1.2. Details of the physiographic features and infrastructures available in and around the lease/block area shall be submitted correctly.

2.1.4.3. Average thickness & grade of the various types of limestone in the lithology units shall be submitted.

2.2.2.10. Chemical Analysis annexure details shall be mentioned.

2.2.4.2. Resource Calculation details shall be submitted correctly as per the methodology adopted for calculation.

2.2.5.9. Resource blocked in various structures/area shall be mentioned correctly in the column provided.

2.2.4.13. Reserves/Reserves estimation shall be submitted correctly based on the exploration carried out in the mining lease area.

Chapter 4: Mining Operations

4.1. There is no change in the proposed method of mining w.r.t existing method, whereas some reasons mentioned in the proposed changes. Clarify it.

4.2.1.1. Status of the existing pit shall be submitted.

4.2.2.1. Financial year to be mentioned in the year column instead of year1, year2, etc.,

4.4.5.1. Excavator & loading equipment type shall be mentioned in the relevant column.

4.4.5.3. Drilling machine type shall be mentioned in the relevant column.

4.5.2. Blasting and explosive requirement in mineral not submitted.

Chapter 7: Financial Assurance/Performance security (Area put to use)

Financial assurance plan should be submitted on the basis of area put to use for mining and allied activities and in view of above comments and the amount shall be submitted in the form of Bank Guarantee as per Rule 27 of Mineral Conservation and Development (Amendment) Rules, 2021.

Chapter8: Review of Previous Proposals

8.2. Technical Details

Production proposal details shall be mentioned correctly and proper justification for deviation in the proposed development and production shall be submitted.

8.3.Details of the Socio-Economic review not submitted.

Plans & Sections:

1. Conceptual plan to be prepared for the entire lease area showing UPL, life of the mine, conceptual exploration, pit dimension, land use pattern, status of reclamation and rehabilitation, land use, position of pit, dumps, dump re-handling proposals, green belt development etc. at the end of this 5 year period and at the end of the lease period.
2. Plans and sections not submitted as per the conditions stipulated in CCOM circular No. 01/2021 dated 07.06.2021 & FAQ on format of Mining Plans issued vide CCOM Circular 1/2021 dated 08.09.2021.
3. Approved DGMS common mine boundary plan shall be submitted.
