Subject: Violation of provisions of MCDR, 1988 in respect of your Ramachandrapuram Manganese Mine over an extent of 4.164 ha of Ramachandrapuram village, Terlam mandal, Vizianagaram dist., Andhra Pradesh.

The following provisions of Mineral Conservation and Development Rules 1988, were found violated in your above mine during inspection on 20.10.2016 by Smt. Ch.Suseela, Assistant Mining Geologist., IBM accompanied by Yourself.

13(1)	Every holder of a mining lease shall carry out mining operations in accordance with the approved mining plan with such conditions as may have been prescribed under sub-rule (2) of rule 9 or with such modifications, if any, as permitted under rule 10 or the mining plan or scheme approved under rule 11 or 12 as the case may be.	The following mining operations were not carried out in accordance with the approved Scheme of Mining approved vide letter No. AP/VZNR/MP/MN-97/Hyd dated 28.5.2015 for the period 2014-15 to 2018-19 and thereby violating the provisions of MCDR,1988. (i)Against the proposal of drilling 7 core bore holes during the year 2015-16, no such drilling has been carried out.(Ref 1.0 (f) of part-A of the approved document)
45(5)(a)(i)	The owner, agent, mining engineer or manager of every mine, shall submit online to the Regional Controller of Mines in the Indian Bureau of Mines or any other authorised official of the Indian Bureau of Mines, returns in respect of each mine, in the following manner, namely: (i) A monthly return which shall be submitted before the 10th day of every month in respect of the preceding month in electronic form, along with a print copy of the same	Monthly returns for the month of September 2016 to November 2016 have not been submitted to the Regional Controller of Mines, Indian Bureau of Mines, Hyderabad so far as required under this rule.
45(5)(b)(i)	The owner, agent, mining engineer or manager of every mine, shall submit online to the Regional Controller of Mines in the Indian Bureau of Mines or any other authorised official of the Indian Bureau of Mines, returns in respect of each mine, in the following manner, namely: (i) An annual return which shall be submitted before the 1st day of July each year for the preceding financial year in electronic form, along with a print copy of the same	Annual Return for the year 2015-16 has not been submitted to the Regional Controller of Mines, Indian Bureau of Mines, Hyderabad so far, as required under this rule.

02. In this connection, it is brought to your notice that the above said violations constitute an offence punishable under Rule-58 of MCDR, 1988. Besides, inability to comply the provisions of rules 13(1), 45(5)(a)(i), 45(5)(b)(i) is also liable for suspension of mining operations under the provisions of Rule 13(2) and 45(7)(i)(a) of MCDR, 1988 respectively.

- O3. You are, therefore, directed to **show cause** within a period of 30 (thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence or the mining operations should not be suspended under Rule 13(2) and 45(7)(i)(a) of MCDR, 1988.
- 04. Please note that no further notice will be given to you in this regard.
