Sub: Violation of provisions of Mineral Conservation & Development Rules, 1988 in respect of your Khatkurbahal limestone & dolomite mine, over an extent of 72.439 hectare in Sundergarh District.
Sir,

The following provisions of MCDR,1988 were found violated in your above mine during inspection on 07/12/2016 by undersigned in presence of Mine officials Sri Anil Kumar Jha, Mine Manager.

Rule No.	Nature of violations observed
13(1)	Mining operations have not been carried out in accordance with the Scheme of Mining, approved vide this office letter number MS/OTFM/17-ORI/BHU/2011-12 dated 21.12.2011 to the extent given below: 1) Mining operation is proposed to carry out by maintaining bench height & width 5m. Whereas during inspection it is observed that on northern part of the quarry bench height is maintained about 8-9m. 2) The benches in waste and ore has not been kept sufficiently advance and bench width is maintained 3-4m which is less than proposed width i.e 5m. 3) During inspection it is observed that plantation proposed in the year 2015-16 are not being carried out.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 58 of Mineral Conservation and Development Rules, 1988.
03. The mining operations can be suspended under rule 13(2), if compliance of rule 13(1) is not found satisfactory.
04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
