The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in the above mine during the inspection on 04/12/2021 by the undersigned in presence of the mine officials Shri N. Jaya Bharata Reddy, General Manager (Mines) and Shri L. Somasekhar Reddy, Manager (Mines).

	Exploration: During F.Y. 2019-20; it was proposed to drill 25 nos. of boreholes with cumulative depth of 830.0 meters, whereas, 08 nos. of borehole with cumulative depth of 188.50 meters have been drilled so far.
	Protective Measures:
	There was a proposal given in the approved document for fencing during F.Y. 2019-20 to 2020-21 in Block no. 1: Length: 300 m and Height: 2.0 m in between local co-ordinates (i) W303, N3030, W4, N2 (ii) E17, N75, E37, N307
	Whereas, fencing has not been done so far.

- 02. In this connection, it is brought to your notice that the violation of aforesaid rule constitutes an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
