Sub: Violation of provisions of MCDR, 1988 (amended up to 2011) in respect of your Madhi Limestone Mine over an area of 10.117 Ha in Raipur District of Chhattisgarh State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 1988 was found violated in your above mine during inspection on 15.12.2016 by the undersigned accompanied by Shri Ashok Sarin, Mine Owner

Rule	Nature of Violation observed
12(3)	The scheme of mining ought to have been submitted to the competent authority at least one hundred twenty days before the expiry of the five years period, for which it was approved on the last occasion. The Scheme of Mining for the Mine was approved on 11.10.2010 for a period of 2009-10 to 2013-14. The proposed period of approved Mining Plan expired and no Scheme of Mining/ Review of Mining Plan was submitted to the competent authority for the subsequent periods.
13(1)	Mining operations should have been undertaken in accordance with the approved Mining Plan/Scheme of Mining. Since you have no approved Scheme of Mining for your above mentioned Mine, it is evident that the mining operations are not being carried out in accordance with the approved Scheme of Mining.

02. It is brought to your notice that the above said violations constitute an offence punishable under Rule-58 of MCDR, 1988. Besides, inability to comply the provision of Rule 13(1) attracts provisions of Rule 13(2) which are liable for suspension of mining operations under rule 13(2) of MCDR, 1988.

03. You are advised to rectify the above violations immediately and intimate the position to this office within **45 (forty five)** days from the date of issue of this letter.
