The following provisions of the MCDR, 1988 were found violated in your above mine during the inspection on 27.10.2016 by undersigned in presence of the mine officials Shri Manoj Kumar, Manager Mine.

13(1)	Every holder of a mining lease shall carry out mining operations in accordance with the
	approved mining plan with such conditions as may have been prescribed under sub-rule
	(2) of rule 9 or with such modifications, if any, as permitted under rule 10 or the mining
	plan or scheme approved under rule 11 or 12 as the case may be.
	It was observed that as per the approved SoM there is exploration proposal to drill two numbers of vertical boreholes of 100 mts each from 148MRL to intersect 48MRL and the same has not been completed.

2. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of Mineral Conservations and Development Rules, 1988.

- 3. The mining operations can be suspended under rule 13(2), if compliance of rule 13(1) is not found satisfactory.
- 4. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
