Sub: Violation of provisions of Mineral Conservation and Development Rules, 1988 in respect of your GUMGAON Mine (Mine code 40MSH14006) (Lease No-I Area 48.60 HA, Lease No -II Area 1.33 HA, and Lease No -III Area 35.97 HA) located in Saoner -Thane, District- Nagpur, Maharashtra.

Sir,

The following provisions of the MCDR, 1988 were found violated in your above mine during the inspection on 28.10.2016 by undersigned in presence of the mine officials Shri AnilSingh Rajput, Manager(geology) Gumgaon Mine.

Rule No.	Nature of violations observed

13(1)	Every holder of a mining lease shall carry out mining operations in accordance with the approved mining plan with such conditions as may have been prescribed under sub-rule (2) of rule 9 or with such modifications, if any, as permitted under rule 10 or the mining plan or scheme approved under rule 11 or 12 as the case may be.

It was observed that as per the approved SoM there is exploration proposal to drill 8(Eight) numbers of boreholes in the year 2015-16 and only 2 (two) been completed and also in the year 2014-15 against 8 (Eight)boreholes 3(three) drill holes have been completed.

2. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of Mineral Conservations and Development Rules, 1988.

3. The mining operations can be suspended under rule 13(2), if compliance of rule 13(1) is not found satisfactory.
4. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
