Sub.-Violation of provisions of Mineral Conservation & Development Rules, 1988 in respect of your Lokapur Limestone Mine M.L.No-2486 over an area of 3.64Ha situated in Lokapur-Village, Mudhol-Tq, Distt.-Bagalkot, Karnataka-State

Sir,

The following provisions of Mineral Conservation & Development Rules, 1988 were found violated during the inspection of your above mine on 25/8/2016 FN.

Rule	Nature of Violation Observed
12(3)	The last scheme of mining was approved vide letter No.MSH/MAN-215(KNT)/GOA/2011-12 Dated-26.8.11 for the period of 2011-12 to 2015-16, As such scheme of mining had fallen due for submission on 01.12.2015 for the next five year period from 2016-17 to 2020-21.
45(5)(b)	An annual return for the year 2015-16 which shall be submitted before the 1 st July of the preceding financial year in the prescribed form, But you have not submitted the annual return to this office till. Therefore, you are directed to submit aforesaid return in hard copy and online system immediately through www.ibm.gov.in/index.php/auth/login .
23(E)(2)	A yearly report before 1 st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted to this office.
63	A Self-Appraisal Report to be submitted by owner of the mine under Rule 63 of MCDR, 1988 stating extent of implementation of Approved Mining Plan/Scheme of Mining during the year of 2015-16 along with supporting plans/sections, representative photographs in hard as well as soft copy has not been received in this office.
24(1)	Notice of temporary discontinuance of work in mine in form-D1 has not been submitted to this office till date.
27(4)	The plan and sections required under the rule were not found updated.

02. The suspension of mining operation was already issued by this office dated 29/1/2016 & not revoked till date. The reply furnished vides letters no. Nil dated 12/7/2016 was duly considered and violation of rule 13(1) taken as complied. Even after sufficient time and opportunity; you have not reported compliance of rule 27(4) of MCDR, 88 and during inspection on 25/08/16 aforesaid violation of rules observed & exists in your mine.

03. In this connection, it is again brought to your notice that the above violation constitutes an offence punishable under Rule 58 of MCDR 1988.



05. Please note that no further notice will be given to you in this regard.


