34A	Every lessee having an annual excavation plan of one million tonne or more in a particular year; or leased area of fifty hectare or more, shall carry out a drone survey of the leased area and up to hundred metres outside the lease boundary in the month of April or May every year and submit the processed output [digital elevation model (DEM) and Orthomosaic] images obtained from such survey or any other format as may be specified by the Indian Bureau of Mines in this regard to the Controller General on or before 1st day of July every year.	Drone image as per Rule 34A has not been submitted till date.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
