
उपरोक्त खान का निरीक्षण दिनांक 13.03.2023 को श्री कपिल आनंद ,खान मिलक की उपस्थिति में अधोहस्ताक्षरी द्वारा किया गया था एवं निरीक्षण के दौरान खिनज संरक्षण एवं विकास नियमवाली 2017 के निम्न प्रावधानों का उल्लंघन पाया गया।

11(1)	 Mining Operation were not carried out in accordance with the approved Review and Updation of Mining Plan with Final Mine Closure Plan (FMCP) vide letter no. 614(2)/MS-B-33/97-DDN dated 09-09-2022 to the following extent: 1. As per proposal on page -21 during the year 2022-23, it was proposed to 300 nos of plantation along the lease boundary and 500 Nos plantations on mine out benches but during the inspection it was observed no such plantation was carried out during the year 2022-23 2. As Per FMCP proposals on page 21, during the year it was proposed to be erect 273 meter fencing in mine at 753608E, 3386881N to 753631E, 3386889N but during the inspection it was observed no such fencing work was not carried out in mine.
	 As per FMCP proposal on page -21 during the year 2022-23, it was proposed to be construct stone wall (260 meter) and garland drain (417 meter) along top of mine out pits but during inspection it was found non such work was carried out in the mine. As per proposals it was proposed development of benches from 1417 mRl to 1369 mRL with six meter height but benches height found more than proposals.
26(1)	According to this rule the holder of a mining lease shall have the responsibility to ensure that the protective measures including reclamation and rehabilitation works have been carried out in accordance with the approved mine closure plan or with such modifications as approved by the competent authority. Whereas during the inspection of mine mentioned herein above and also examination of offices record, Plans and Sections etc, it has been found that the protective, reclamation and rehabilitation measures as envisaged in the approved Progressive Mine Closure Plan (PMCP) and Final Mine Closure Plan(FMCP) have not been carried out
