The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in the above mine during the inspection on 21/02/2023 by the undersigned in presence of the mine officials Shri K. U. Jenekar, Mining Engineer & Shri Ajay Nanaji Jagtap, Geologist.

(2)	July every year setting forth the extent of protective and rehabilative works carried out has
	not been submitted for the financial year 2021-22.
Rule 31	The plans and sections have not been maintained up to date.

Rule 33	A dgital copy alongwith a print copy of the surface geological plan and sections has not
	been submitted on or before 30th day of June to the authorised officer for the financial year
	2021-22.
Rule 46	Notice of Certain Appointment: Appointment notice of the Manager (Mines) has not been
	sent in the prescribed format (Form H) to the authorized officer within fifteen days from the
	date of such appointment.

- 02. In this connection, it is brought to your notice that the violation of aforesaid rule constitutes an offence, punishable under Rule 62(1) of MCDR, 2017 as well as Fine may be imposed as specified under Schedule-III of rule 62(2) of MCDR, 2017 Amended up to 3rd November 2021.
- 03. The mining operations and dispatches can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
