Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Shiv Shanthi manganese Mine(40APR20075) over an extent of 4.973 ha. In Garbham Village, Vizianagaram district, Andhra Pradesh.

Sir,

The inspection of the above mine was carried out by sri A.V.Ramesh Kumar, assistant Mining Geologist on 03.05.2023 accompanied by Sri D.Shankarlal Sharma, lessee. During the inspection the following provisions of Mineral Conservation and Development Rules 2017, were found violated in your above mine.


Rule	Nature of Violation
28	<p>“Subject to the provisions of section 4A, the holder of the mining lease shall send to the authorized officer, as the case may be a notice in Form-E when the mining or mineral processing operations in the mine part thereof are discontinued for a period exceeding ninety days so as to reach them within one hundred and twenty days from the date of such discontinuance”</p> <p>It was informed by the lessee that the mining operations are discontinued due to non availability of clearance from State Pollution board and during the inspection also it was noticed that no mining operations are being carried out.</p>

01. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 (1) of MCDR, 2017 as well as fine for amount of Rupees Five lakhs (Rs.5,00,000/-) may be imposed as specified under Schedule-III of rule 62(2) of MCDR, 2017 amended up to 3rd November 2021.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.


