Violation letter

Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Saibaba-I Manganese Mine(40APR20029) over an extent of 8.656 ha in Kothakarra & Budarayavalasa villages in Merkamudidam Mandal, Vizianagaram District, Andhra Pradesh State.

Sir,

The above mine was inspected by Sri A.V.Ramesh Kumar, Assistant Mining Geologist, of this office on 04-05-2023 accompanied by Sri Asok Konda, Nominated owner. During the inspection it is observed that the following provisions of Mineral Conservation and Development Rules 2017, were found violated in your above mine.


Rule	Nature of Violation
11(1)	The Mining operations are not being carried out as per the approved Mining plan document to the extent as indicated below: “(a) It was proposed to drill Five boreholes and Seven boreholes during the years 2020-21 and 2022-23 respectively. However, the same were not drilled. (b) The earlier document was approved on 10.08.2018 and the proposals are valid up to 31.03.2023. The mining operations are carried out without a approved document.” Thus all the mining operations carried out after 31.03.2023 are in violation of section 4a(4) of the Act.

01. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 (1) of MCDR, 2017 as well as fine may be imposed as specified under Schedule-III of rule 62(2) of MCDR, 2017 amended up to 3rd November 2021.

03. Further, inability to comply the provision of Rule 11(1) is liable for suspension of Mining operations under 11(2) of MCDR, 2017.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.


