	have not been completely submitted in accordance with the Standard Operating
	Procedures under sub rule (5) of rule 34A of MCDR, 2017 for carrying out drone
	survey and submission of Digital Aerial Images of Mining areas.
	i)The DTM resolution is 28 cm which should be 15 cm or better as per the SOP.
	ii)The shp files under map of the mining lease area for Waste dump,
	Afforestation and backfill area have not been prepared correctly. The
	nomenclature has also not been prepared/maintained as per the approved plan.
	iii)The soft copy of the output data submission form for the drone survey i.e.,
	Annexure-I with all details have not been submitted.

- The record of 7 nos. of Exploratory boreholes drilled during year 2021-22 were not found maintained properly with all details in "Form-J" as per provision of this rule.
- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR (Amendment), 2021
- 03. You are advised to rectify the above violations immediately and intimate the position to this office **within 45 (Forty-Five) days** from the date of issue of this letter.
