The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during inspection on 20/03/2023 by the undersigned in presence of Shri Anand Mukul Pandey, DGM (Mines), Shri Abhay Kumar Singh, Mine Manager & Satish Kumar Singh, Sr Manager Geology:

	are dug.
	2. 9, 88,000 metric Tons of ROM is raised against the proposal of 12, 00,000
	metric tons.
	3. 33.58 Lakh tons of cement grade limestone is lying as dead stock. No
	bonafide action are taken for disposal of the same.
Rule 55	Employment of geologists and mining engineers(1) For the purpose of carrying out
	reconnaissance, prospecting or mining operations in accordance with these rules, –

Provided that in the case of fully mechanised category 'A' mines, the mining engineers and geologists shall have minimum five years of professional experience of working in a supervisory capacity in the field of mining:

Mining Engineer and Geologist have not been appointed.

Rule 63(1)

Preservation of cores, etc.-(1) Every holder of a mineral concession and every agency authorised under the second proviso to sub-section (1) of section 4 shall preserve intact, until submission of the final geological report, all cores and specimens of different types of rocks and minerals obtained during drilling or sinking operations and shall arrange for them to be laid out in a serial order with identification marks, showing the progressive depth at which, they are obtained.

During the inspection, It is found that the cores & records of old core sample are not available. And the core samples of recent boreholes are not kept systematically. And recent drilled bore holes are not preserved.

- 02. A brief Note may be submitted on the efforts made for reducing the generation of fines (-10mm limestone) as well as disposal of huge quantity limestone fines so far.
- 03. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.
- 04. Non-compliance of the rule 11(1) of MCDR-2017 may lead to suspension of Mining operations under the provisions of rule 11(2) of MCDR-2017.
- 05. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
