Rule 27(2)	<p>The Mineral Conservation & Development (Amendment) Rules, 2021 Notified by Gazette of India, Notification date 03/11/2021. As per Rule 27(1)(i) of Mineral Conservation & Development (Amendment) Rules, 2021, which is for financial assurance the following provisions have been made in the rule which is reproduced as:</p> <p>(i) for the words and letters “three lakh rupees for Category „A” mines and two lakh rupees for Category “B” mines”, the words and letters “five lakh rupees for Category “A” mines and three lakh rupees for Category „B” mines” shall be substituted;</p> <p>Provided that the minimum amount of financial assurance to be furnished under sub-rule (1), shall be ten lakh rupees for Category ‘A’ mines and five lakh rupees for Category ‘B’ mines:</p> <p>Provided further that where financial assurance has already been furnished before the commencement of these rules, an amount equal to the difference between the financial assurance due as on the date of notification of these rules and the financial assurance already furnished, shall be furnished to the authorized officer, as the case may be, within a period of ninety days from the date of notification of these rules:</p> <p>Therefore, additional/difference of Financial assurance for Rs 36,16,000 /- (Rupees- Thirty six Lakhs and sixteen thousand only) by considering the total net area of 18.08 hectares is required to be submitted.
