The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during the inspection by undersigned on 17.03.2023 in presence of Shri Dinesh Dixit, GM (Mines) & Shri M.K. Sen (Mine Manager) detailed as below:

	The Review of Mining Plan of above mentioned mine was approved vide this office letter No-MP/Satna/Limestone/RMP-26/2019-20 dated 23.01.2020 for the proposals period from 2020-21 to 2024-25 and following deviations/violations have been observed during mine inspection in accordance with approved proposals of ROMP- i) During approved plan period from 2021-22 to 2022-23 the production of Limestone were proposed in following manner

	Category "A" mines and three lakh rupees for Category "B" mines" shall be substituted;				
	Provided that the minimum amount of financial assurance to be furnished under sub-rule (1), shall be ten lakh rupees for Category 'A' mines and five lakh rupees for Category 'B' mines:				
	Provided further that where financial assurance has already been furnished before the commencement of these rules, an amount equal to the difference between the financial assurance due as on the date of notification of these rules and the financial assurance already furnished, shall be furnished to the authorized officer, as the case may be, within a period of ninety days from the date of notification of these rules:				
	Therefore, additional/difference of Financial assurance for Rs 93,32,000 /- (Rupees- Ninety Three Lakhs and thirty two thousand only) by considering the total net area of 46.66 Hectares is required to be submitted. (Financial assurance of Rs- 1,39,98,000 already submitted in last ROMP approved on dtd 23.01.2020)				

Rule 31(4)	The plans and sections required under these rules shall be maintained up to date within three months in case of category 'A' mines as referred to in clause (a) of sub-rule (2) of rule 55, and within twelve months in case category 'B' mine
	The plans & sections were not found updated and maintained at mines site office.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.
- 03. Non-compliance of the rule 11(1) of MCDR, 2017 may lead to suspension of mining operations under the provisions of rule 11(2) of Mineral Conservation and Development Rules, 2017.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
