Subject: -Violation of provisions of provisions of Mineral Conservation & Development Rules, 2017 in respect of your **Hinauti limestone Mine** over an area of **378.271 hect**; situated in District of Satna of M.P.State.

Sir,

Undersigned has inspected your mine in the presence of re-presentative of lessee, Mines officials and QP on 13/05/2022. Following provisions of MCDR 2017 were found violated in your mines at the time of inspection.

Rule.	Nature of violations observed.
11(1) of MCDR, 2017	<p>Mining operations under mining lease.– (1) No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government .</p> <p>The Modification in Approved Mining Plan of above mentioned mine was approved vide letter No.-MP/Satna/Limestone/ MPLN/MOD-15/2020-21 dated 21/12/2020 incorporating proposals of working from 2020-21 to 2021-22.</p> <p>(a) Boundary pillars are not maintained as per Rule 12(v) of MCR 2016. (b) Very less plantation has not been done against the proposal. (c) At some places Waste dumps and top soil has not been stacked seperately.</p> <p><i>Therefore, there is violation of rule 11(1) of MCDR,2017 and non compliance of rule 11(1) of MCDR,2017 may lead to suspension of Mining operations under the provisions of rule 11(2) of MCDR,2017.</i></p>

In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.

The mining operations can be suspended under the rule 11(2) of MCDR-2017, if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.

You are advised to rectify the violations of above mentioned rules immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
