The following provisions of the Mineral Conservation and Development Rules, 2017 read with Mineral Conservation and Development (Amendment) Rules, 2021 in your above mine during inspection on 15.02.2023 by Shri. Gangadhar Bhakat, AME in the presence of Sri. Abdul Khadeer, Mining Engineer.

Rule	Nature of violations observed
11 (1)	The Mining operations are required to be carried out in accordance with the approved Modified Review and Updation Mining Plan document vide letter no. 279/345/92/BNG dated 29/06/2020, However, during the inspection deviations were observed in mining operation vis-à-vis approved document and are as follows: (i) For the Year 2021-22, It was proposed to produce 14,50,000 Tones of Limestone Ore (ROM). It has been observed that, only 1,55,440 Tones of ROM production has been achieved. It is deviation of 90% from the proposed quantity.
26(2)	A yearly PMCP report as per the format specified by the Indian Bureau of Mines has not been submitted before 1st July 2022 setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved progressive mine closure plan.
33	Updated Surface plan, Geological Plans and Sections as per the Rule 32 of MCDR, 2017 are not submitted on or before 30th June 2022 for the year 2021-2022.
