- 02. The Mining operations and dispatches may be suspended and any action under sub-rule (7) of Rule 45 of MCDR 2017 read with MCDR (Amendment), 2021 may be initiated.
- 03. The late submission of Star rating template fine amount under Rule 35(4B) of MCDR (Amendment), 2021 to be paid @ Rs. 10,000/- per day i.e., Rs. 10,000 x 7 days = **Rs, 70,000** (**Rupees seventy thousand only**). The said penalty is to be paid through **https:/bharathkosh.gov.in** web portal under the purpose head "Non filing of Star Rating Template" in favour of "137321 **Regional Controller of Mines, IBM Bangalore''**.
- 04. The late submission of Annual Return fine amount under Rule 45(7) of MCDR (Amendment), 2021 to be paid @ Rs. 10,000/- per day i.e., Rs. 10,000 x 5 days = **Rs, 50,000 (Rupees fifty thousand only).** The said penalty is to be paid through **https:/bharathkosh.gov.in** web portal under the purpose head "Non submission/faulty Monthly Returns" in favour of "137321 **Regional Controller of Mines, IBM Bangalore".**
- 05. In this connection, it is again brought to your notice that this violation also constitutes an offence punishable under Rule 62 of MCDR (Amendment), 2021.
- 06. You are, therefore, directed to show cause within a period of thirty (30) days from the date of issue of this notice, as to why action under sub rule (7) of Rule 45 and Rule 62 of MCDR 2017 read with MCDR (Amendment), 2021 shall not be taken against you.
- 07. You are herewith given **30 days**-time for reply and rectification of the violation from the date of issue of this notice. Please note that no further notice will be given to you in this regard.
