The following provisions of Mineral Conservation and Development Rules, 2017 were found violated during inspection of the above mine on 22.06.2023 by the undersigned alongwith Shri S K Mahaptra, AME in presence of Shri Sri Prabodh Kumar Mohanty, Mine Owner and the mine officials Sri T. C. Sei (Mines Agent), Sri S. K. Pyar Mohammad (Mines Manager).

Rules	Nature of violations observed
11(1)	Mining operations in the mining lease are not being carried out in accordance with as per the proposal given in approved Modification of review of Mining plan dated 20.10.2020 to the extent given below; i) It has been proposed for production from Three (03) nos of pits (quarry) during the year 2022-23. However during inspection it is observed that the entire production carried from one quarry. Other 02 quarries were not operated during the year 2022-23. ii) It has been proposed for 34008 tons of Bauxite production during FY 2022-23, However during inspection it is observed that, Bauxite production is NIL during the year 2022-23. iii) It has been proposed for backfilling of 0.353 ha during the year 2022-23. However during inspection it is observed that, no backfilling has been carried out within the proposed backfilling area.
