

विषय : छत्तीसगढ़ राज्य के कांकेर जिले में स्थित आपके हहालदी लोह अयस्क खान 66.00 हैक्टर में खनिज संरक्षण एवं विकास नियमावली 2017 एवं 2021 के नियमों के संबंध में।

महोदय,

आपकी उपरोक्त खान का निरीक्षण दिनांक 16.02.2023 को अधोहस्ताक्षरी द्वारा आपके प्रतिनिधि श्री सरयू तिवारी, की उपस्थिति में किया गया तथा खान के निरीक्षण के उपरांत पाया गया कि आपने खनिज संरक्षण विकास नियमावली 2017 एवं संशोधित नियमावली 2021 के निम्नलिखित नियमों का उल्लंघन किया है।

नियम	उल्लंघन के प्रकार का विस्तृत ब्यौरा						
11(1)	The Mining operations required to be carried out in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines. However, Mining operations observed not carried out in accordance with the Review & updation of Mining Plan (RMP) approved dated: 20.05.2021 to the extent indicated below:  i. Exploration was proposed to be carried out by drilling of 47 nos. of core boreholes in FY 2021-22 & 2022-23. However, exploration as proposed has not been carried out so far.  ii. In year 2021-22 & 2022-23, temporary fines dump/stack of 05 m height was proposed at earmarked place between grid line 2242166 to 2242385. However, it is observed during inspection that, temporary fines dump has been made confined to grid line 2242350 to 2242500 by increasing its height of about 10 to 15 mt. Further, this fines dump/stack has not been found terraced at 3 -5 m interval along height as envisaged. Moreover, no any environmental protection measures (retaining wall, garland drain, sieved culvert, siltation tank etc.) observed constructed around the said fines dump as envisaged in approved RMP. (Refer text and plate no. 08 of RMP)  Hence, above are observed to be against the systematic & scientific development of mines and also against the protection of environment in the mine.						
26(2)	A yearly report setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, ought to be submitted before the 1st day of July each year for the preceding financial year, has not been submitted so far for the year 2021-22.						
31(4)	The Plans & sections have not been maintained up to date within three months as required under this for Category 'A' mines; as Updated Plans & sections have not made available during the inspection.						
35(2)	Every holder of a mining lease shall monitor his mining and allied activities as per the template of star rating in the format specified in this behalf by the Indian Bureau of Mines from time to time, and shall submit online its self-assessment report before the 1st day of July every year for the previous financial year. However, it is observed that you have not submitted the self-						

	assessment report for the above referred mine within the prescribed date as specified in this Rule. Details of delay in submission of template of star rating by you are enumerated as below:

<b>45</b> (5)	The holder of a mining lease shall submit online returns in respect of each mine to the Regional Controller and the authorized officer of the Indian Bureau of Mines in the following manner namely:-  An annual return which shall be submitted before the 1 <sup>st</sup> day of July each year for the preceding financial year in electronic form, along with a signed print copy of the same. Details of delay in submission of annual return by you are enumerated as below:

55	Full time Mining Engineer and Geologist have not been appointed as required under this rule.								

- 02. It is brought to your notice that non-compliance of Rule 35(2) of MCDR, 2017, attracts provisions of Rule 35(4A) & (4B) of MCDR, 2017 under which:
  - (i) The mining operations may be suspended.
  - (ii) The holder of mining lease shall be liable to pay an amount of ten thousand rupees per day for such delay to the authorised officer of the Indian Bureau of Mines in case of non-filling/delay in filling of template of Star Rating.
- 03. Further, action according to Rule 45(7) of MCDR, 2017 can be initiated, if compliance of Rule 45 is not found satisfactory.
- 04. You are therefore directed to deposit the amount for aforesaid delay in submissions at the earliest through Bharatkosh Portal (<a href="https://bharatkosh.gov.in">https://bharatkosh.gov.in</a>).
- 05. इस संदर्भ में आपका ध्यान आकर्षित किया जाता है कि उपरोक्त नियमों का उल्लंघन खनिज संरक्षण एवं विकास नियमावली 2017 एवं संशोधित नियमावली 2021 के नियम 62 के अंतर्गत दंडनीय अपराध है एवं उपरोक्त नियमों का अनुपालन नहीं होने पर आपके विरूद्ध अभियोग याचिका दायर किया जा सकता है एवं खनिज संरक्षण एवं विकास नियमावली 2017 एवं संशोधित नियमावली 2021 के नियम 11(2) एवं 45(7) के अंतर्गत खान की समस्त खनन संक्रियाएं बंद की जा सकती है।
- 06. अतः आपको सलाह दी जाती है कि आप उपरोक्त नियमों का उल्लंघन का अतिशीघ्र सुधार करें एवं इसके सुधार की सूचना इस पत्र के जारी होने से 45 दिन के भीतर इस कार्यालय को सूचित करें।
