The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during MCDR inspection on 21.06.2023 in the presence of Sri.M. Tickamchand Khimsura, Director & Sri. R. Shakthivelu, Manager.

	Mining operations are not carried out in accordance with the proposals given in approved Modification of Mining Plan vide letter No. 659(562)/Ver/2007/NLR dated 20.04.2021to the extent indicated below.		
	i. It was proposed to drill 02 Nos. core boreholes in the year 2021-22, 04 Pits in the year 2022-23, whereas no exploration work carried out as per proposal.		
	ii. It was proposed to excavate ROM of 952 tonnes in the year 2021-22 & 964 metric tonnes in the year 2022-23, whereas no production carried out in the year 2021-22 and 1055 tonnes of production reported in the year 2022-23.		
	iii. It was proposed to plant 50 Nos. of saplings in the year 2022-23, whereas no plantation work carried out as per proposal.		
	iv. It was proposed to construct Retaining wall and garland drain of 35meter each in the year 2022-23, whereas no retaining wall construction done as per proposal		
	iv. It was proposed to carry out environmental monitoring on half yearly basis. However during inspection it was noticed that environment monitoring work was not carried out.

- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.


